4. (A) Municipal tax bill for address of home with correct name on bill. (B) Rent receipt, copy of lease showing parent or legal person's name and address. Also landlord's or superintendent's name and written certification of the guardian/child being legal residents. (See enclosed)
5. Proof of custody of said child/children (birth certificate, adoption or custody papers)
6. If the current legal name is different from birth certificate, person must provide proof of name change, certified marriage certificate, divorce papers - court evidence.
