Annual Integrated Pest Management Notice 2016-2017 School Year

Dear Parent, Guardian or Staff Member:

This notice is being distributed to comply with the New Jersey School Integrated Pest Management Act. The Nutley School District has adopted an Integrated Pest Management (IPM) Policy and has implemented an IPM Plan to comply with this law. IPM is a holistic, preventative approach to managing pests that is explained further in the school's IPM Policy, which is available at each school.

All schools in New Jersey are required to have an Integrated Pest Management Coordinator (IPM Coordinator) to oversee all activities related to IPM and pesticide use at school.

The IPM Coordinator maintains the pesticide product label and Material Safety Data Sheets of each pesticide product that may be used on school property. The label and the Material Safety Data Sheets are available for review by a parent, guardian, staff member or student attending the school.

Also, the IPM Coordinator is available to parents, guardians and staff members for information and to discuss comments about IPM activities and pesticide use at the school.

As part of the pest management plan, The Nutley School District may use pesticides to control pests. The United States Environmental Protections (DEP) registers pesticides to determine that the use of a pesticide in accordance with instructions printed on the label does not pose an unreasonable rise to human health and the environment. Nevertheless, the EPA and DEP cannot guarantee that the registered pesticides do not pose any risk to human health. Thus unnecessary exposure to pesticides should be avoided. The EPA has issued the statement that where possible persons sensitive, such as pregnant women, infants and children, should avoid necessary pesticide exposure.
